1. Approve 2018 Budget

Gary Landis made a motion, seconded by Keith Martin to approve the 2018 Budget as advertised. * The motion was unanimously approved.

2. Approve Resolution to Reduce Tax Millage Rate Due to Re-Assessment

Keith Martin made a motion, seconded by Gary Landis to approve Resolution 122617 to reduce the tax millage rate from 1.30 to 1.087 due to the 2018 county re-assessment. * The motion was unanimously approved.

3. Approve Resolution to Increase 2018 Tax Millage Rate

Gary Landis made a motion, seconded by Keith Martin to approve Resolution 122617A to increase the 2018 tax millage rate from 1.087 to 1.17. * The motion was unanimously approved.

This increase will generate approximately \$43,266. Expenses have risen due to inflation, police related expenses and Stormwater MS4 Regulations Compliance. This tax millage increase will allow the Township to continue to preserve capital reserve fund monies for road and other capital projects and to provide for the necessities of General Government.

4. Building Code Appeals Board Member

After discussion, the Board of Supervisors authorized the Township Manager to contact Josh Reist to see if he would be interested in serving on the board.
