#### **New Business**

1. Accept Non-Uniformed Pension Plan Audit 2017 - 2020

Bruce Leisey reviewed the Audit with the Board of Supervisors. Bruce Leisey informed the Board of Supervisors of a Finding of incorrect Data Certification on Form AG 385 in 2019. This error resulted in an overpayment of State Aide.

After discussion, Gary Landis made a motion, seconded by Keith Martin to accept the Audit report with the Finding and authorize Bruce Leisey to refund the overpayment from the State Aide in the amount of \$4,902 plus interest earned on the monies through 1/25/2022. \* The motion was unanimously approved.

## 2. Approve Use of Meeting Room for Polling Place

Bruce Leisey reviewed the request with the Board of Supervisors.

Keith Martin made a motion, seconded by Gary Landis to approve request from the Lancaster County Board of Elections to use the meeting room on 5/16/22 and 5/17/22 as an election polling location. \* The motion was unanimously approved.

#### 3. Discussion on Purchase of Loader Forks and Power Washer

After discussion, Gary Landis made a motion, seconded by Keith Martin to approve purchase of Karcher Electric Hot Water Pressure Washer from Kochel Equipment, Elverson in the amount of \$5,300 and used loader forks from JL Hollinger, Manheim in the amount of \$3,000. \* The motion was unanimously approved.

## 4. Approve and Execute ECHO Housing Agreement – 40 Wissler Road

Bruce Leisey reviewed the request with the Board of Supervisors. Bryan Moser is requesting permission to renovate the garage at 40 Wissler Road to be used as ECHO Housing. The Zoning Officer determined their plan meets the requirement of the Township's ECHO Housing requirements.

Gary Landis made a motion, seconded by Keith Martin to approve and execute the ECHO Housing Agreement for 40 Wissler Road, Ephrata. \* The motion was unanimously approved.

#### Bills to be Paid

Keith Martin made a motion, seconded by Gary Landis to approve payment in the amount of \$34,980.30 for General Fund bills and \$174.00 for Sewer Fund bills. \* The motion was unanimously approved.
