Plan Review

1. Refreshing Mountain Camp & Marlin Harnish - Sketch Plan

Justin and Marlin Harnish reviewed the sketch plan with the Planning Commission.

The proposed project includes removing a 1,900 sq ft portion of a meeting room and a 50X50 sq ft section of paving. It also proposes a new code compliant updated restroom building 12X50 sq ft similar is size to the existing building which will be removed. These proposed improvements will be located on the parcel owned by Refreshing Mountain Camp.

The proposed project also includes building a new 40X52 sq ft meeting room, adding an access drive and 2 ADA parking spaces on an adjacent lot owned by Marlin and Sharon Harnish. The total proposed impervious on this lot would be 8,280 sq ft.

There was discussion on a possible waiver of land development, storm water management, access, parking, water, sewer and easements between the two separately owned parcels. There was also discussion on doing a lot add on to the parcel owned by Refreshing Mountain Camp.

It was agreed that Bob Lynn and Bruce Leisey would draft a listing of items needing addressed for the proposed project to be in compliance with Township zoning, land development and stormwater regulations.

These items would be discussed at the next meeting.
