Clay Township Park Rules and Regulations *[amended per Ord. 111307, 11/13/07]*

§101. Rules and Regulations for all Clay Township Parks. *[Ord. 01-12885, 01/28/1985 as amended by Ord. 04-13-92B, 04/13/1992, §1]; [amended per Ord. 111307, 11/13/07]*

§102. Applicability. The provisions of this Part shall apply to all parks owned by the Township, including all future acquired parkland in the Township of Clay and any other land the Township devotes the same to park usage. *[Ord. 01-12885, 01/28/1985, §1 as amended by Ord. 04-13-92B, 04/13/1992, §2]; [amended per Ord. 111307, 11/13/07]*

§103. Vehicles. No vehicle of any kind (including, but not limited to, bicycles, motorcycles, minibikes, snowmobiles, motor vehicles, trucks, motor driven tricycles, etc.) is permitted at any place in Park, except for on duly established roads and parking facilities. Unlicensed motorized vehicles (including, but not limited to, motorcycles, snowmobiles, and motor scooters) are prohibited from any location in Park. *[Ord. 01-12885, 01/28/1985, §2]*

§104. Animals Prohibited. No horses, dogs, cats, sheep or any other type of livestock or domesticated or nondomesticated animals are permitted in Park at any times, unless said are wild animals dwelling in their native habitat. *[Ord. 01-12885, 01/28/1985, §3]*

§105. Alcoholic Beverages and Controlled Substances Prohibited. Possession or consumption of alcoholic beverages or controlled substances of any kind is prohibited in Park. *[Ord. 01-12885, 01/28/1985, §4]*

§106. Firearms, Firecrackers, and Bows and Arrows Prohibited. Possession or use of fire arms, firecrackers, or bows and arrows of any kind is prohibited in the Parks. *[Ord. 01-12885, 01/28/1985, §5] [Amended by Ord. No. 071408, 7/14/08]*

§107. Discarding Waste Materials. No person shall place or otherwise dispose of any trash, garbage, rubbish or any litter within Park except in containers duly marked for disposal of such materials. *[Ord. 01-12885, 01/28/1985, §6]*

§108. Conduct and Noise. Loitering, vandalism, disorderly conduct, reckless driving or noisy vehicle operation in Park at any time is prohibited. *[Ord. 01-12885, 01/28/1985, §7]*

§109. Open Fires Prohibited. Open fires are prohibited in Park. *[Ord. 01-12885, 01/28/1985, §8]*

§110. Hours. Park shall be closed from one-half (1/2) hour following sundown until the following 7:00 a.m. Any person present in Park, at any location, other than during the aforesaid hours, shall be considered and is hereby declared to be a trespasser. Notwithstanding the foregoing, the Supervisors or Park and Recreation Commission may extend the hours of permissible Park use for scheduled programs and events. *[Ord. 01-12885, 01/28/1985, §9]*

§111. Car Washing, Polishing, Waxing or Repairing Prohibited Unless Permitted. Except with prior permission of either the Board of Supervisors or the Park and Recreation Commission, no car washing, polishing, waxing or repairing is allowed in Park. *[Ord. 01-12885, 01/28/1985, §10]*

§112. Smoking Prohibited. Smoking is prohibited in all Clay Township Parks. See Chapter 10, Part 3 of this Code of Ordinances, which sets forth provisions prohibiting smoking in all Clay Township Parks. [*added by Ord. No. 071408, 7/14/08*]

§113. Violations and Penalties. Any person, firm or corporation who shall violate any of the provisions of this Part shall, upon conviction thereof, be sentenced to pay a fine of not less than Ten Dollars (\$10.00) nor more than Three Hundred Dollars (\$300.00) and the costs of prosecution for each and every offense; provided, however, that each day's violation of any provisions of this Part shall constitute a separate offense; and, provided further, however, that upon anyone giving notice of a violation, whether verbal or in writing, the continued violations during the day after such notice is given shall also constitute a separate offense. §114. Validity. Provisions of this Part are severable, and, if any of its provisions are held to be illegal, such illegality shall not affect or impair any remaining provisions of this Part. It is hereby declared to be the legislative intent of the Board of Supervisors of Clay Township that this Part would have been adopted had any such illegal provision not been included herein.
