1. Nolt Spreading LLC - Waiver of Land Development

They would like to construct a 9,360 square foot building to store their existing fertilizer products to keep them dry and have easier access to load. They currently load outdoors, and the timing is affected by the weather.

The property is zoned LI. The business is family owned and there will be no additional employees added as a result of this project. In fact, the process will require less manhours in the new building.

There are currently minimal retail sales and that would not change with this project.

Business hours will remain from 7:00 am to 4:30 pm, and they are not expecting any additional traffic to be generated.
